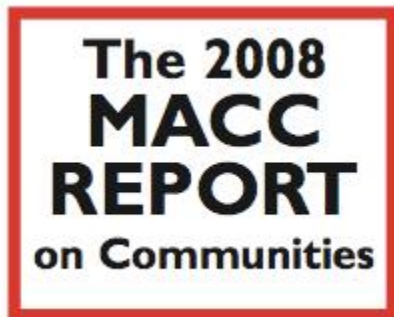

## Report on Communities



The 2008 MACC Report on Communities, a first survey of employees of MACC Alliance of Connected Communities 20 Twin Cities members, dramatically reveals the natural integration of social issues facing residents of the Greater Twin Cities Metropolitan Area. This MACC sponsored survey uniquely gathers data from over 400 front line workers and agency administrators, offering a snapshot of the multiple, intertwined issues that are barriers to success for thousands of Twin Cities residents and their families, as well as the neighborhoods in which they live. The information was presented to a meeting of legislators at the Capitol on January 15, 2008.

Among the findings:

- ✓ The top five reasons individuals and families are referred to MACC agencies are:
  - Education

- Employment
- Housing
- Violence / safety
- Health- physical or mental

Some issues which do not rank highly as a primary reason why individuals and families are referred to an agency often rise in importance when you look at the additional issues that emerge when MACC's front line employees interview new clients. Of particular note is the transportation issue.

This research makes it clear that a single issue approach to serving clients will not move us toward our goal of building strong communities. In addition, it gives us a huge amount of data that can be sliced and diced in various ways to demonstrate the complexities that exist in the lives of the individuals and families our agencies serve. MACC believes this will help us obtain critical support from legislators and funders to invest in holistic programs that work. ### MACC Civic Engagement Initiative 2008 launched

MACC is excited to report the launch of its 2008 civic engagement effort! Throughout the year MACC agencies will find regular resources to increase civic engagement, and enthusiastic encouragement for staff and community members to get involved. MACC staff Sharon Haas will lead this effort, in partnership with Susie Brown, from member organization Family & Children's Service.

This year started with an effort to train people — staff and community members — to participate in the precinct caucus process, Minnesota's earliest and most local entry point into participation in the democratic process. And we're so excited that we did! With all of the attention and news about turnout and political involvement throughout the nation on February 5, we're glad to have helped some people understand the process and become involved. What a day that was for democracy!

On February 12 the Minnesota legislative session began, and as it progresses we will provide information and encouragement for organizations, their leadership, staff and clients, to attend various "Days on the Hill" as they are relevant to the communities you serve. These are organized opportunities to come together with a group of like-minded people to raise the voice of organizations and community members on specific issues. These days often include rallies, educational opportunities, and meetings with legislators. They're fun and effective! On February 14 MACC members attended the Minnesota Council of Nonprofits Day on the Hill, to talk to legislators about nonprofit property tax exemption. In late February and March there will be "Days on the Hill" related to domestic violence, affordable housing, immigration and other issues of interest to MACC agencies. We hope you'll be involved! After the session you'll hear from us about opportunities to get involved in the upcoming elections, through voter registration, voter education and get out the vote. These activities will be significant and important as there are critical voting decisions to be made by the community in local and national races such as school board, House of Representatives, and of course U. S. President.

### MACC Staff Development offerings in 2008

The MACC Staff Development Team is pleased to offer a number of valuable workshops to MACC agency staff in the beginning of 2008. MACC workshops coming up include:

- **Responding to Child Maltreatment — Mandatory Reporting and Intervention options**  
(Thursday, Feb. 28, 9-12 at Minnesota Indian Women's Resource Center)

This workshop covered Maltreatment definitions, mandated reporter responsibilities, and how to make a report. In addition, a practitioners panel, made up of Carrie Heim, Tubman Family Alliance; Michelle Ness, Neighborhood House; and Blenda Smith, Phyllis Wheatley Community Center, discussed making wise choices, supporting children, how to support parents, and other considerations.

- **Ethical Issues in Practice: Dilemmas and Decisions**  
(Monday, March 24, 2-4pm at East Side Neighborhood Services)

This is an interactive scenario-based session, focused on a wide variety of work settings with many different populations. The session is designed to meet the ethics requirement for Licensed Social Workers, but is open to any staff member at any level of an organization who has ever struggled with an ethical dilemma (basically everyone).

- **Essentials of Supervision**  
(Tuesdays and Thursdays, May 6 — 22, Tubman Family Alliance).

This course is designed for social service agency staff who work in a supervisory role at various levels of the agency, including staff members who play a direct service role, but also supervise others in the direct service role. This includes program managers, and department heads who supervise groups of staff. It can also include volunteer coordinators who supervise volunteers and interns. We recommend that supervisors not attend the course with supervisees.
